- I am a non-citizen who entered the US after my 26<sup>th</sup> birthday.** Attach documentation from USCIS showing original date of entry into the United States. This date must be after the student's 26<sup>th</sup> birthday. (This date may be different than the date the student received permanent resident status.)
- I am a non-citizen who entered the US as a lawful nonimmigrant on a valid visa and remained in the US on the terms of that visa until after my 26<sup>th</sup> birthday.** Attach documentation of proof of entry into the U.S. in the form of an entry date stamp on the I-94 form or in your passport, or a letter from USCIS indicating the entry date. Also include documentation of the valid nonimmigrant visa with the expiration date. This could be a student visa or valid passport with U.S. visa stamp including expiration date (the dates must be from entry, until after the student turned 26).
- I did not register with the Selective Service as required between age 18 & 25.** Attach your **Status Information Letter** received from the Selective Service, along with an appeal that explains why you did not register for the Selective Service. You are not eligible for financial aid unless your appeal is approved by the Office of Student Financial Aid & Scholarships.
